

## Winter Resolution 2018 Sweepstakes

### OFFICIAL RULES

**No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.**

**Promotion Period:** Winter Resolution 2018 ("Sweepstakes") begins January 1, 2018 and ends February 28, 2018. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.
