

Summer Shine a Light 2017 Sweepstakes

OFFICIAL RULES

No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.

Promotion Period: Summer Shine a Light 2017 ("Sweepstakes") begins July 1, 2017 and ends August 31, 2017. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

How to Enter: Individuals will receive an automatic entry into the Sweepstakes when they log into FORT MCCLELLAN CREDIT UNION MONEY MINDER between July 1, 2017 and August 31, 2017, and have added at least one account to their account overview. One entry per household.

Winners need not be present and will be notified by e-mail, mail or telephone within 5 business days of selection.
